Thursday, March 10, 2011	March monthly activities report (all lobbyists filing monthly)	February 1, 2011, <i>or</i> January 1, 2011, if first activities report*	February 28, 2011
Monday, April 11, 2011 <i>Deadline extended because of weekend.</i>	April monthly activities report (all lobbyists filing monthly)	March 1, 2011, <i>or</i> January 1, 2011, if first activities report*	March 31, 2011
Tuesday, May 10, 2011	May monthly activities report (all lobbyists filing monthly)	April 1, 2011, <i>or</i> January 1, 2011, if first activities report*	April 30, 2011
Friday, June 10, 2011	June monthly activities report (all lobbyists filing monthly)	May 1, 2011, <i>or</i> January 1, 2011, if first activities report*	May 31, 2011

* If you file your initial lobby registration after January 1, 2011, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on May 4, 2011, that registrant's first monthly report (due by June 10, 2011) would cover the period beginning January 1, 2011, and ending May 31, 2011.

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

* If you file your initial lobby registration after January 1, 2011, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on May 4, 2011, that registrant's first monthly report (due by June 10, 2011) would cover the period beginning January 1, 2011, and ending May 31, 2011.
