Monday, March 11, 2024 <i>Deadline is extended because of weekend.</i>	March monthly activities report (all lobbyists filing monthly)	February 1, 2024, <i>or</i> January 1, 2024, if first activities report*	February 29, 2024
Wednesday, April 10, 2024	April monthly activities report (all lobbyists filing monthly)	March 1, 2024, <i>or</i> January 1, 2024, if first activities report*	March 31, 2024
Friday, May 10, 2024	May monthly activities report (all lobbyists filing monthly)	April 1, 2024, <i>or</i> January 1, 2024, if first activities report*	April 30, 2024
Monday, June 10, 2024	June monthly activities report (all lobbyists filing monthly)	May 1, 2024, <i>or</i> January 1, 2024, if first activities report*	May 31, 2024

* If you file your initial lobby registration after January 1, 2024, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2024, that registrant's first monthly report (due by April 10, 2024) would cover the period beginning January 1, 2024, and ending March 31, 2024. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***

If you are ever confused about the beginning date for a required report, remember this rule for reporting: **There should never be gaps between reporting periods and there should never be overlaps.**

Tuesday, November 12, 2024 <i>Deadline is extended because of weekend and holiday.</i>	November monthly activities report (all lobbyists filing monthly)	October 1, 2024, <i>or</i> January 1, 2024, if first activities report*	October 31, 2024
Tuesday, December 10, 2024	December monthly activities report (all lobbyists filing monthly)	November 1, 2024, <i>or</i> January 1, 2024, if first activities report*	November 30, 2024
Friday, January 10, 2025	January monthly activities report (all lobbyists filing monthly)	December 1, 2024, <i>or</i> January 1, 2024, if first activities report*	December 31, 2024
Friday, January 10, 2025	Annual activities report (all lobbyists filing under the modified reporting schedule who were registered in 2024)	January 1, 2024	December 31, 2024

* If you file your initial lobby registration after January 1, 2024, your first activities report must cover the reporting period beginning January 1 and ending on the last day of the month in which you register (or ending on December 31 if you file annually). For example, if a registrant first registers on March 4, 2024, that registrant's first monthly report (due by April 10, 2024) would cover the period beginning January 1, 2024, and ending March 31, 2024. ***Electronic reports must be filed by midnight, Central Time Zone, on the night of the filing deadline.***
